- Beginning and ending balances must be the same as the bank statements.
- You must bring the original bank statements. We are required to keep these in our office for 30 days. We will make copies and you can pick the originals up after 30 days.
- You must mail a copy of the Annual Return to all heirs, beneficiaries, and surety for the bonding company if applicable, and sign the attached sheet in front of a notary public acknowledging that you did so.
