TIPS:

- If there is more than one conservator, both co-conservators must sign.
- All signatures must be signed in front of a notary or signed in front of one of the Probate Court clerks.
- All beginning balances must be the same as the ending balances on the previous return. If this is your first return, your beginning balance should be zero.
- Beginning and ending balances must be the same as the bank statements.
- You must bring the <u>original bank statements</u>. We are required to keep these in our office for 30 days. We will make copies and you can pick the originals up after 30 days.
