Vice-Chair Baggett opened the meeting at 9:02 a.m. and Chaplain Lamb gave the invocation.

Vice Chair Baggett recognized Commissioner Brown who made a motion to approve the minutes of the May 27, 2025, meeting. Commissioner Vonier seconded the motion. The motion was approved unanimously with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, Gross voting aye.

Vice Chair Baggett recognized Commissioner Grady who made a motion to approve the agenda for the June 10, 2025, meeting. Commissioner Rich seconded the motion. The motion was approved unanimously with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, Gross voting aye.

Vice-Chair Baggett recognized Jeff Jones, a developer residing at 108 Old Field Court, Thomasville, GA. Mr. Jones presented the Board of Commissioners with site plans for a proposed residential development located off State Road 122. He explained that 42 of the planned lots may qualify for a state grant aimed at supporting infrastructure development. Homes within this subdivision are expected to be priced between approximately \$200,000 and \$290,000. Vice-Chair Baggett then acknowledged Aurora Taylor, representing Grants Management & Community Development Consulting. Ms. Taylor explained that Mr. Jones intends to apply for a state infrastructure grant to help offset development costs. She noted that the grant operates on a quarterly funding cycle and requested the county's support in submitting a pre-application. Due to the need for additional information, Vice-Chair Baggett recognized Commissioner Brown, who moved that Ms. Taylor gather further details and return to present them at the next Public Works Committee meeting, scheduled for June 18, 2025, at 8:30 a.m. Commissioner Hickey seconded the motion. The motion carried unanimously, with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, and Gross voting aye.

Vice-Chair recognized Commissioner Grady who made a motion to reappoint Carla Defnall to the Library Board for a second term. The term will expire on June 30, 2028. The motion was seconded by commissioner Vonier. The motion carried unanimously with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, and Gross voting aye.

Vice-Chair recognized Commissioner Grady who made a motion to reappoint Jennifer Green to the Department of Children and Family Services Board. The term will expire on June 30, 2030. The motion was seconded by commissioner Vonier. The motion carried unanimously with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, and Gross voting aye.

Reports: County Manager Stephenson recognized Zoning Administrator, Donna Holbert who introduced zoning Application #25-6-1 Britt Stephens, Jet Development, LLC, Owner/Manager, has applied to rezone property located on Patterson Still Road. This property is owned by Jet Development, LLC consisting of 37.96 acres, more or less, and is located on Thomas County Map 045, Parcel 259B. The request is to rezone the subject property from R-4 (CSD) Conservation Subdivision Development to R-1 (Single Family Residential) to allow for the subdivision of the property into three single family residential lots.

Donna Holbert introduced zoning Application #25-6-2 Hunter Neel, Neel & Sons Tree Service, LLC, Owner, has applied for a conditional use zoning for property located at 1994 County Line Road. This property is owned by Neel and Sons, LLC and is located on Thomas County Map 055, Parcel 013 consisting of 5.13 acres, more or less. A 1.85 acre, more or less, portion of the parcel is zoned CL (Commercial Limited.) The request is for a conditional use on the 1.85 acre, more or less, portion of the property to allow for a tree service. If approved, the 1.85 acre, more or less, portion of the property will be classified as CL (Commercial Limited) C.U. (Conditional Use, Tree Service.)

<u>Committees:</u> Vice-Chair Baggett recognized Commissioner Vonier who made a motion to ratify the purchase of regular fuel from Petroleum Products for \$2.2045 per gallon on June 2, 2025. Commissioner Brown seconded the motion. The motion was approved unanimously with Vice-Chair Baggett and Commissioners Grady, Vonier, Rich, Brown, Hickey, and Gross voting aye.
