Counsel for each party shall confer and submit to the court, in writing, **no later than \*FRIDAY, DECEMBER 5, 2025**, the contentions of the parties, the time estimated in hours to try the matter, and whether the presence of a court reporter is required. **NO ANNOUNCEMENTS WILL BE ACCEPTED AFTER THE DECEMBER 5TH DEADLINE. If counsel fails to confer, then appearance by both counsel will be required at the pre-trial conference.**


