If no such announcement is received by the deadline, counsel for all parties shall attend the pre-trial conference.

NON-JURY TRIALS:

In order to be excused from the pre-trial conference portion of this calendar, counsel for each party will need to submit, in writing, a **JOINT** letter to the Court, no later than WEDNESDAY, December 11, 2024, outlining the contentions of the parties, the time estimated to try the matter, and whether the presence of a court reporter is required. Otherwise, counsel will be required to attend the pre-trial conference. If counsel fail to confer and submit a **JOINT** announcement then appearance by both attorneys shall be required at the pre-trial conference. Unless so notified by the Court, counsel for all parties shall attend the scheduled pre-trial conferences.

STATUS CONFERENCE CASES:

On the Status Conference portion of this calendar, all counsel and pro se parties will be required to attend in person unless a final order is submitted to the Court no later than Thursday, December 12, 2024. Unless so notified by the Court, counsel for all parties shall attend the scheduled status conferences.
