If counsel fail to confer and submit a <u>JOINT</u> announcement then appearance by both attorneys shall be required at the pre-trial conference. Unless so notified by the Court, counsel for all parties shall attend the scheduled pre-trial conferences.

On the Status Conference portion of this calendar, all counsel and pro se parties will be required to attend in person unless a final order is submitted to the Court no later than Thursday, December 12, 2024.
