In order to be excused from the pre-trial conference portion of this calendar, counsel for each party will need to submit, in writing, a **JOINT** letter to the Court, **no later than Friday, June 12, 2026** outlining the contentions of the parties, the time estimated to try the matter, and whether the presence of a court reporter is required. Otherwise, counsel will be required to attend the pre-trial conference. **Unless so notified by the Court, counsel for all parties shall attend the scheduled pre-trial conferences.**

STATUS CONFERENCE CASES:

On the Status Conference portion of this calendar, all counsel and pro se parties will be required to attend in person unless a final order is submitted to the Court no later than **Friday, June 12, 2026.** **Unless so notified by the Court, counsel for all parties shall attend the scheduled status conferences.**
