Counsel for each party shall confer and submit to the court, in writing, **no later than \*TUESDAY, AUGUST 26, 2025**, the contentions of the parties, the time estimated in hours to try the matter, and whether the presence of a court reporter is required. **NO ANNOUNCEMENTS WILL BE ACCEPTED AFTER THE DECEMBER 10TH DEADLINE. If counsel fails to confer, then appearance by both counsel will be required at the pre-trial conference.**

**\*STATUS CONFERENCES:**

Cases designated for a status conference are listed on this calendar. **ALL COUNSEL MUST ATTEND THE STATUS CONFERENCE IN PERSON. NO EXCEPTIONS.** The only exception would be a filed final order, which would need to be delivered to the Court prior to December 17, 2024.
