Vice-Chairman Brown recognized Commissioner Hickey who gave the invocation and led the Pledge of Allegiance to the Flag.

Vice-Chairman Brown recognized Commissioner NeSmith who made a motion to approve the minutes to the 9/11/2018 board meeting. Commissioner Hickey seconded the motion. 
