The Thomas County Board of Commissioners met on the above date in a regular scheduled meeting at 6:00 p.m. at the Historic Courthouse, Commission Chambers, with the following board members present:

Staff present was County Manager Michael J. Stephenson, Bruce County Attorney Warren, and County Clerk Twink Monahan. No news media was present.

Chairman Grady recognized Commissioner Rich who made a motion to approve the minutes of the April 9, 2019 board meeting. The motion was seconded by Commissioner Brown. Motion carried unanimously; Chairman Grady, Vice-Chairman Brown, Commissioners Gross, Hickey, NeSmith, Rich and Baggett aye.

Commissioner NeSmith made a motion to appoint Wiley Grady to the Thomasville-Thomas County Land Bank Authority Board until Commissioner Vonier is able to resume his roll on the board. The motion was seconded by Commissioner Baggett and approved unanimously. Ayes: Chairman Grady, Vice-Chairman Brown, Commissioners Gross, Hickey, NeSmith, Rich and Baggett.

Commissioner NeSmith made a motion to ratify the 4/11/2019 purchase of diesel from Petroleum products at \$2.1470 7,500 gallons. The motion was seconded by Commissioner Hickey and approved unanimously. Ayes: Chairman Grady, Vice-Chairman Brown, Commissioners Gross, Hickey, NeSmith, Rich and Baggett.

The Chairman called for Public Comments, there were none.

Chairman Grady recognized Commissioner Baggett who made a motion to enter into closed executive session for consultation with the county attorney to discuss a legal matter. Chairman Grady recognized Commissioner Hickey who made a motion to re-enter into open session reporting there is no action to be taken.
