Chairman NeSmith called the meeting to order, and Corey McGee gave the invocation.

Chairman NeSmith recognized Commissioner Brown who made a motion to approve the minutes of the January 28, 2025 Board Meeting. Commissioner Hickey seconded the motion. The motion passed unanimously with Chairman NeSmith, Commissioners Baggett, Brown, Grady, Hickey, Rich, and Vonier voting aye.

Chairman NeSmith recognized Commissioner Baggett who made a motion to approve the agenda for the February 11, 2025 Board Meeting. Commissioner Vonier seconded the motion. The motion passed unanimously with Chairman NeSmith, Commissioners Baggett, Brown, Grady, Hickey, Rich, and Vonier voting aye.

Chairman NeSmith recognized Ken Gay who made the recommendation to approve the Final Plat for Pecan Farms Phase II. He stated that all of the necessary requirements have been met.
