- Declared Public Hearing Capital Improvements Element: Thomas County Board of Commissioners to consider a resolution transmitting a draft Capital Improvements Element 2023 Annual Update report, relating to the County's impact fee program, to the Southwest Georgia Regional Commission for regional and State review pursuant to the Georgia Planning Act of 1989.

- Open Meeting to the Citizens: Chairman Vonier recognized Ucher Dent of 408 Pine Street, Ochlocknee, Georgia who asked for support for the local Juneteenth celebration--the observance honoring the end of slavery. As founder and organizer of the local chapter. Ms. Dent stated that the annual event will be held at the Deep South Fairgrounds and invites all races to come and celebrate the enslaved people of America. She asked for monetary sponsorship and consideration for the County to observe Juneteenth as a holiday. Chairman Vonier recognized Earl Williams, III of 211 Yorkshire Crescent, Thomasville, Georgia who echoed the sentiments of Ms. Dent. Along with a personal testimony he described the Freedom Festival as impressive, welcoming, friendly, and great camaraderie among citizens.
