SCHEDULE OF RATES FOR DRIVEWAY INSTALLATIONS
NOVEMBER 2, 2021

These rates apply if the County installs the driveway. The installation fees below are based on standard 24' length driveways. If extra length is required, there will be additional charges. Any driveway that requires larger diameter pipe than 24", cost will be calculated. Prices subject to change with increased pipe cost.

OPTION: You may choose to have a private contractor install your driveway on a county-maintained road. Contractor must obtain permit for installation from Thomas County Public Works. Attached is a list of Thomas County's approved contractors you can use. You may not go outside of this list. If you choose this option, there is a \$100 permit fee. If you choose a contractor to install your driveway on a state route, there will not be a permit fee.

County maintained paved roads – metal pipe (flare end sections required)

15", 18", 24" diameter pipes \$2,320

County maintained dirt roads – metal pipe

15", 18", 24" diameter pipes \$1,730

State routes – installed only with a GDOT permit

18" \$3,652

24" \$4,743

DRIVEWAY INSTALLATION APPLICATION AND PERMIT PROCESS

NOVEMBER 2, 2021

COUNTY MAINTAINED ROADS

1. Fill out driveway application at Thomas County Public Works or Building Inspection Office. Applicant will be given a schedule of rates for Public Works to install the pipe, and a list of approved contractors.
2. Building Inspection will submit application to Public Works.
3. Public Works superintendent will meet applicant on site to determine what will be required for a proper installation.
4. Public Works will generate a driveway permit with the size/length pipe/cost for county to install.
5. The property owner will either -
 - a. Pay the amount as quoted by the County for the County to install
 - b. Pay the \$100 permit fee if they choose for a private contractor to install
6. If private contractor is selected, property owner is responsible for making sure contractor meets with Public works prior to any work beginning.
7. Once driveway installation is completed by contractor or Public Works forces, Public Works will issue a notice of acceptance to the property owner, Building inspection and the contractor.

STATE ROUTES

1. Property owner must first contact DOT in Moultrie (229-891-7130). DOT will issue a permit for their road.
2. After DOT permit has been issued, it is up to the property owner to decide if they want County Forces or a private contractor to install.
3. If property owner chooses for County to install driveway on a State Route, property owner will –
 - a. Pay the amount as quoted by the County for the County to install
4. If property owner chooses a private contractor to install driveway on a State Route, Public Works is hands off from this point.
