



Thomas County Government
Resuming Normal Operations
Public Access Limitations

Revised - effective 2 June 2020

Pursuant to the Governor’s Executive Order of 29 May, lobby and reception areas in County facilities, will be open to the public, and normal operations will resume, except as noted below. Everyone entering a County facility will be required to wear a mask or face covering and exercise reasonable social distancing. County Staff will regularly clean surfaces in their work areas, as needed. Hand sanitizer will be conveniently available and masks will be provided for visitors to our offices.

Judicial Center – 325 North Madison Street

- Georgia Supreme Court Chief Justice Howard Melton has ordered the Judicial Center remain open, though specific functions may be postponed or cancelled. Access to office areas may be limited.
- Masking, social distancing and sanitary requirements may be modified from time to time, pursuant to Court orders.

Thomas County Historic Courthouse – 225 North Broad Street

- Tax Commissioner and Tax Assessor’s Offices lobby areas will be open to the public, but office area will remain closed to the public.
- The County Commissioners’ Office will remain open to the public.
